Foundation's Newest Home

In July 2019, the Foundation purchased it's newest home; Fairway House (pictured below) in Fort Scott. Due to a recent influx of individuals coming in for residential services, there was a need for additional houses for our neighbors with intellectual/developmental disabilities.

More especially, the Foundation saw a need for four + bedroom homes in all four counties, but primarily in Fort Scott. Thanks to help from a former Foundation Board Member, the Foundation was able to find a home in Fort Scott.

Following the purchase of the home, plans for a remodel were finalized. The remodel will make the home more efficient and bring it up to date.

The remodel should only take a few months. Once completed,

four very excited people will move in to their new home. Once they are settled, the Foundation will hold an Open House so that all our "Friends" may see what they have helped the Foundation accomplish: providing quality and affordable homes for our neighbors with intellectual/developmental disabilities.

Kansas City Chiefs Tickets Fund-raiser

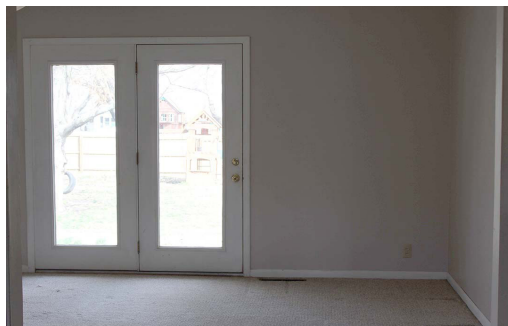
